**Qualifications & Instructions**

The Grand Court of Ohio, Order of the Amaranth, awards several \$500.00 scholarships annually to qualifying youth. The success of our fund-raising determines the number of scholarships awarded.

**Qualifications**

Applicants must be high school seniors or undergraduate students of a university, college or technical college.

Applicants who are selected to receive a scholarship will be notified by the first week of May, 2017. At that time, we will discuss arrangements for your attendance at the Grand Court opening ceremonies on May 18<sup>th</sup>, 2017.

**Instructions**

All applications forms must be completed by printing or typing. All parts must be completed. If "not applicable", please enter N/A,

**Attachments**

At the top of each attachment to your application, please be sure that your full name and address are clearly visible.

High School transcripts are required from ALL high school applicants. If you have completed advanced schooling, you must submit transcripts from your school(s). If you are unable to obtain a transcript, secure an affidavit from a school official attesting to your scholastic standing.

Submit a **FINANCIAL PLAN** for the upcoming school year. Include an estimate of expenses (e.g. tuition, fees, room and board, transportation, books) and planned income (e.g. your earnings, portion from your savings and investments, parental assistance and other scholarships). **How are you personally helping yourself financially? How will your expenses for school be covered?**

## **Page 2 Qualification and Instructions**

Compose a letter describing your extracurricular activities at school, church and service/fraternal organizations. Be specific as to the offices held and awards earned. Include all activities in high school and/or college. The letter must be signed by the High School Counselor/college representative or adult advisor of your youth organization, include current personal reference letters from two (2) sources dated within the last year (not from relatives).

Submit the application with all attachments to the Chairperson of the Scholarship Committee **POSTMARKED NO LATER THAN APRIL 1, 2017.**
