

## Ohio International Order of the Rainbow for Girls Web Site Rules

All Ohio Rainbow for Girls web sites must follow these rules in order for the site to be linked to the official Ohio Rainbow for Girls web site and/or the Supreme Assembly web site. This form must be completed and forwarded to the Ohio Grand Assembly webmaster, Robin Jackson, by mail at 8942 Hill Ave. Holland, OH 43528. Your site will be reviewed by the Ohio Grand Assembly Web Site committee and recommendations made to Mom. Morris.

### Ohio Web Site Rules

1. The official Rainbow emblem must appear on the home page.
2. A contact e-mail address for the webmaster must appear on the home page.
3. All Ohio Rainbow web sites must include an allegiance statement to the Supreme Assembly on the home page.  
 "This web site acknowledges allegiance to the Supreme Assembly, International Order of the Rainbow for Girls, whose seat of authority is in McAlester, Oklahoma, USA, of which Reverend W. Mark Sexson was the founder, Mrs .Dorothy Brillhart, Florida, USA, is Supreme Worthy Advisor and Mrs. Janice Morris is Supreme Deputy in Ohio."
4. The District web site must have the approval of the District's Grand Deputy.
5. If the webmaster is a Rainbow girl, then an adult web site advisor will be appointed.
6. There will be no personal information of ACTIVE Rainbow Girls posted on the web site.
  - a. No postal address.
  - b. No e-mail address
  - c. Grand Worthy Advisor's e-mail address only with proper written approval.
  - d. No telephone numbers.
7. When identifying girls in pictures, only first names may be used. No individual pictures, group only.
8. The name, e-mail address and postal address of the webmaster and official contact person must be on file with the Grand Assembly webmaster and must be kept up to date.
9. A e-mail address for contact information is permitted IF the contact is an adult. If girl's e-mail addresses are linked or used, the listing must be on a page within a web site, and have password protection.
10. Individual/personal web sites are not to be linked to the Ohio Rainbow web site.
11. Advertisements for non-Rainbow related items on Ohio Rainbow web sites are not allowed. (Example: Geocities, Angelfire, Tripod and such other site providers who require advertisements on your site. Those can and have led to inappropriate sites.)
12. Content of Ohio Rainbow web sites will not be derogatory to the International Order of the Rainbow for Girls, or to any of the girls who are members of the IORG or its adult advisors.
13. Open web rings are not to be used or linked.
14. Annually in March the webmaster of each Ohio Rainbow web site will fill out this form, updating information as necessary with the proper signatures and mail it to Robin Jackson, Grand Special Committee, at the address at the top of this form.
